Mixed waste storage operations detailed

DOE requests RCRA Permit Renewal

The U.S. Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) modifications to Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volume VIII, which details operations at the Mixed Waste Storage Buildings and Waste Storage Pads. DOE is also submitting Volume XXV (Solvent Storage Tanks) of the application. This is a first-time submittal for this volume.

The revision (Rev. 1 of Volume VIII) incorporates the installation of a remote handling system for the processing of mixed transuranic wastes and general administrative changes.

This notice begins a 60-day comment period. More information, including the actual permit application, is available for review and copying at the US DOE Public Reading Room located in the University of South Carolina-Aiken library, or by contacting personnel listed below. The permittees compliance history during the life of the permits being modified is available from the Agency.

A public meeting will be held November 7 at 2 p.m. at the Aiken County Public Library. Representatives from SRS will be available to answer questions. Written comments may be

sent to SCDHEC. All comments will be considered in the final decision.
