Hazardous Waste Permit Modification Requested

The Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) modifications to Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volume I and Volume XIII. Volume I of the application contains general information about each of the permitted facilities at SRS and information that is common to many of the facilities. Volume XIII details operations at the TRU Pads 3-6, 14-17 and 26.

The revisions (rev. 12 of Volume I and rev. 3 of Volume XIII) request approval to process, treat, store and repackage hazardous only waste and corrosive wastes at TRU Pads 3-6, 14-17 and 26. These revisions also requested a number of other minor changes.

This notice begins a 60 day comment period. More information, including the actual permit applications, is available for review and copying at the DOE Public Reading Room located in the University of South Carolina-Aiken Library or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.
